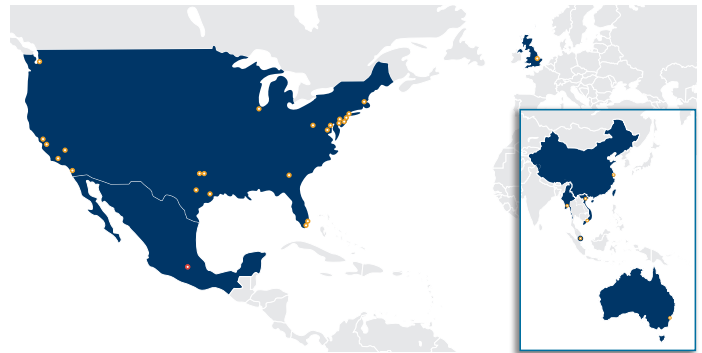


## NOTABLE TRANSACTIONS AND PROJECTS

- ▶ Represented **GI PARTNERS** in connection with a **\$389 MILLION** CMBS loan for **ONE WILSHIRE**, a data-center property in downtown Los Angeles. One Wilshire is among the largest and most significant telecommunications hubs in the country, connecting to an underground fiber-optic network that provides internet service throughout the U.S. and serving as a key connection point to the Pacific Rim.
- ▶ Represented **TOLL BROTHERS** in a joint venture project, with an affiliate of **PGIM REAL ESTATE**, to develop a 376-unit apartment building with a 431-space parking garage in Atlanta; represented Toll on the equity side and acted as local counsel on the debt side.
- ▶ Representing **PLENARY INFRASTRUCTURE PHILADELPHIA** in connection with the **\$425 MILLION** adaptive reuse/renovation of the William H. - ▶ Representing **POTTSTOWN SUSTAINABLE ENERGY PARK LLC** in connection with a significant renewable biodiesel project in Pottstown, Pennsylvania, consisting of a **\$650 MILLION** P3 project that could be a blueprint for nine other plants; plant converts wood and cellulose to energy and is located in an Opportunity Zone.
